### • NFOD Flash Report

### Drug Deaths- DD reviews

This report highlighted the issue that 50% of Drug Deaths had a NFOD, and this is a gap which is under investigation.

ER fed in the delays in reports to the National Drug Deaths Incident Management Team, and this needs to be resolved at a National level so there is consistency across Scotland. ER requested feedback from the group.

PH looking in to the issue of Bupronorpheine as it is higher in lanarkshire. Lanarkshire has always been a higher prescriber.

Action: DDPG to look at the additional data around drug deaths which including Bupronorpheine, and prescribing, and take in to account daily dosing during Covid.

NFOD – The following items were discussed around the NFOD Figures:

- Discussions around what can we do differently to get people in to services. Need to understand why people do not engage with services, can we provide any themes?
- Factual information required around the Covid years and the contribution to drug deaths.
- Profile the deaths and why they have not engaged in services, and ensure including outreach and disengagement to understand the gaps, and look at the provision of services in these areas.
- A review required of the number of who also have psychiactric conditions.

It was agreed that the reports can be shared internally only.

Chief Executives - Pan Lanarkshire Suicide and Drug Death event. FM to provide data for North and South lanarkshire.

#### • Alcohol Specific Deaths Update Report

Highlighted the need for a support or service to support problematic alcohol abuse, and this will be picked up through the Pan Lanarkshire Alcohol Related Harm group.

ACTION: GB to speak to MW about the alcohol pack re the language used.

	LS asked about alcohol related brain damage, and this will be taken in to account in the review for the service in the Care and Treatment Group. A gap analysis required. There is a service in Glasgow that can be used as a model for the service.  LP requested a session on alcohol for the board, with more of a focus on the partner side.  ER advised that there is capacity within Public Health to support needs assessment data, reviews of alcohol related death.
